## Juried Artist Member Benefits

Artists who have attained the distinction of Wickford Art Association's Juried Artist Member will receive the following benefits with their annual membership:

- Eligible to be included in a Juried Artist Member Invitational Show at the gallery.
- Application fee discount on a booth at the Wickford Art Festival.
- Discounts on WAA classes and workshops.
- Eligible to submit 4 pieces in the gallery Browse Bins.
- Eligible to submit up to 20 greeting cards for sale in the gallery.
- Direct link from WAA website to Juried Artist Member's website.
- Artist's biography/statement featured in the association's member reference book.
- The opportunity to display and sell artwork at offsite locations.
- Eligible for Featured Juried Artist of Month.

**Juried Artist Member membership is \$60/annually (July 1st – June 30<sup>th</sup>).**

General Artist Members in good standing for a minimum of 6 months may be considered for Juried Artist Membership. Jury panels for Juried Artist Membership consideration are held several times per year – please contact the gallery for the next available panel date. Applicants will submit 5 pieces of fine art on the assigned date and the jury panel consists of three (3) WAA Juried Artist Members. The panel will mail you their decision within three weeks. The gallery will contact you to retrieve your work after the panel meets.

Please note that as of December 31, 2017, WAA will no longer use the method of attaining Juried Artist Membership by being accepted into four juried WAA shows.
